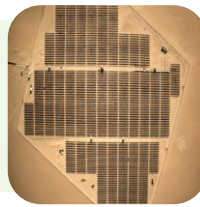




Supplementary declaration to the HSSE and quality policies

Protect the environment, including pollution prevention and other specific commitments resulting from an analysis of our situation.



Consultation and participation

Encourage consultation and promote the participation of employees through their representatives in the occupational health, safety and well-being management system.
